Live Video Reimbursement	
<p>No reference found.</p>	<p>Reimbursement is made for exams performed via a real-time interactive audio and video telecommunications system. The patient must be able to see and interact with the off-site practitioner during the exam. A medical professional is not required to be present with the client at the originating site unless medically indicated.</p> <p><i>Source: WY Dept. of Public Health Insurance, Medicaid, General Provider Information, p. 107-108 (Dec. 11, 2014).</i></p> <p>Eligible providers:</p> <ul style="list-style-type: none"> • Physicians; • Advanced practice nurses with a specialty of psychiatry/mental health; • Physician's assistant (billed under the supervising physician); • Psychologists and neuropsychologists; • Mental health professionals (LCSW, LPC, LMFT, LAT). • Speech therapist <p>Provisionally licensed mental health professionals cannot bill Medicaid directly, but must provide services through a supervising provider.</p> <p>For end-stage renal disease-related services, there must be at least one in-person exam per month of the vascular access site.</p>

	<p>Quality assurance/improvement activities relative to telehealth delivered services need to be identified, documented and monitored.
