STATE LAW/REGULATIONS	MEDICAID PROGRAM
Definition of telemedicine/telehealth	
<p>Telemedicine means the use of interactive audio, video, or other telecommunications technology that is:</p> <ul style="list-style-type: none"> Used by a health care provider or health care facility to deliver health care services at a site other than the site where the patient is located; and Delivered over a secure connection that complies with the requirements of HIPPA. <ul style="list-style-type: none"> The term includes the use of electronic media for consultation relating to the health care diagnosis or treatment of a patient in real time or through the use of store-and-forward technology. The term does not include the use of audio-only telephone, e-mail, or facsimile transmissions. <p><i>Source: MT Code Sec. 33-22-138.</i></p> <p>Telemedicine means the practice of medicine using interactive electronic communication information technology, or other means between a licensee in one location and a patient in another location with or without an intervening health care provider. Telemedicine typically involves the application of secure videoconferencing or store-and-forward technology, as defined in 33-22-138. The term does not mean an audio-only telephone conversation, an e-mail or instant messaging conversation, or a message sent by facsimile transmission.</p> <p><i>Source: MT Code Sec. 37-3-102.</i></p>	<p>Telemedicine is the use of interactive audio-video equipment to link practitioners and patients located at different sites.</p> <p><i>Source: MT Dept. of Public Health and Human Svcs., Medicaid and Medical Assistance Programs Manual, General Information for Providers (Sept. 2017). Live Video Reimbursement	
<p>Private payers are required to provide coverage for services delivered through live video, equivalent to in-person coverage.</p>	<p>MT Medicaid reimburses for medically necessary telemedicine services to eligible members. Providers must be enrolled in Medicaid.</p>
